WEATHERFAST A1 PENETRATING TIMBER OIL

DESCRIPTION:	A penetrating timber oil which will nourish the timber whilst eradicating any organic growth deep within the substrate. Contains biocides and UV inhibitors.
USES:	Primary use is to penetrate deep inside the timber to replenish the oils and eradicate any organic growth.

CLEAN UP: Weatherfast Brushing Thinners

PREPARATION: The timber **MUST** be clean and dry before commencing. If the timber is grey, use Norglass Grey-Away prior to coating. Any further cleaning of the surface should only be done with Norclean-Plus using a **paper towel.**

- APPLICATION: Stir contents thoroughly before use. Apply using a brush or roller (short nap 4mm mohair), 2-3 coats every 30 minutes on the same day. Do not thin. Allow to dry for 2 days before a light sand with 240 grit sand paper, clean with Norclean-Plus then apply A2 finishing coat if required.
- **TRANSPORTATION:**DG Class 3 HAZCHEM 3Y P.G.IIISizes available 10litre, 4litre, 2litre, 1litre.
- **PRECAUTIONS:**Provide adequate ventilation during use.Keep away from naked flame and do not smoke.Do not use in damp conditions or below 10 C.
- FIRST AID:If poisoning occurs call a doctor or Poisons Information Centre (Aust) on 13 11 26 or
